Treasurer's report</li> <li>The Treasurer's report for 2021 was presented by Jessica Welch.</li> <li>The Association recently appointed RP Hosking, Registered Tax Agent, to review it accounts, including previously non-reviewed annual accounts from 2019 and 2020.</li> <li>Reviewed accounts from 2019 and 2020 were tabled at this AGM and will be retained in the Association's records.</li> <li>The Accounts for 2021 were presented, noting a significant improvement in the Association's financial position over the year due mostly to receipt of a government gran and fundraising revenue. A significant change during the year was moving the uniform shop online.</li> </ul>
